A RESOLUTION

CREATING A CITY COUNCIL ADVISORY AD HOC COMMITTEE REGARDING THE DEVELOPMENT DIALOGUE

WHEREAS, the City Council of the City of Lakewood is authorized by the Lakewood Home Rule Charter to establish ad hoc advisory committees by resolution; and

WHEREAS, the City Council wishes to establish a City Council Advisory Ad Hoc Committee to identify and propose amendments to the zoning code, review staff and Planning Commission recommendations, and develop redlined changes for Council's consideration and adoption; and

WHEREAS, the Committee's purview will include Parking and Related Infrastructure, Architectural Design and Green Buildings, Mixed-Use Developments and Site Design/Community Context; and

WHEREAS, the City Council Advisory Ad Hoc Committee on the Development Dialogue will consist of one council member from each of the City's five wards.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Lakewood, Colorado, that:

SECTION 1. The Lakewood City Council Advisory Ad Hoc Committee on the Development Dialogue is hereby established. The City Council Advisory Ad Hoc Committee on the Development Dialogue shall commence work on June 12, 2018 and end on January 8, 2019.

SECTION 2. The purpose of the Committee is to make recommendations to the entire City Council regarding possible amendments to the zoning code, as recommended to the Committee by the Planning Commission.

SECTION 3. Members of the City Council **Development Dialogue** Ad Hoc Committee are hereby appointed as follows:

SECTION 4. This Resolution shall become effective immediately upon its adoption.
