Pre-assemble for Demonstrator space is scheduled for Friday, September 30, 2016, between the hours of 10:00 am and 7:00 pm. Demonstrator vehicles will be allowed 20 minutes in the designated loading / unloading area each day before the event and after the event. **There is no reserved parking.** Demonstrator shall remain open during the festival hours of 10:00 am to 5:00 pm, Saturday, October 1, 2016, and Sunday, October 2, 2016. Demonstrator vehicles may not be allowed back in the designated loading / unloading area until after 5:30 pm each day. Demonstrator must request in advance if electricity is required. Failure to comply with all City of Lakewood ordinances, site and event policies & procedures and/or Cider Days staff instructions or requests may be grounds for immediate expulsion from the event and preclusion from participation in future events.*
