1. SFRE, Single Family Residential Equivalent.
2. The Lakewood Commercial/Industrial tap fee is determined by the total number of fixture units divided by 20 (rounded up to the nearest integer) and multiplied by \$2,600. For example, a property with 54 proposed fixture units would have a tap fee of \$7,800 (54/20=2.7→3.0; 3.0 x \$2,600 = \$7,800).
3. For fixtures not listed, Fixture Units may be estimated by comparing with devices using similar quantities and rates of water.
