



## Police force to grow with proposed 2018 Annual Budget

The proposed 2018 Annual Budget will allow the Police Department to add four sector liaison agents and one sector liaison sergeant, which will increase this specialized unit to 10 agents in the Patrol Division.

The Sector Liaison Unit focuses on crime prevention, intervention, enforcement and mediation of community issues to improve the quality of life for Lakewood residents and business owners. These additional agents will focus on the challenging community issues of homelessness, mental health and sex offender registration, allowing this unit to expand its efforts in these areas.

"Homelessness has been on the increase in Lakewood and surrounding communities. Yet at the same time, calls involving mental health issues are some of our most difficult to handle, while tracking where sex offenders live is extremely important to residents," said Police Chief Daniel McCasky. "Adding these agents to concentrate our efforts on these concerns will help the department better serve the community."

The annual budget for the last two years has added 16 agents to the Police Department, and the proposal for next year would bring to 21 the number of positions added to the department in the last three years.

The proposed 2018 budget would add a DNA analyst who would be assigned to the Jefferson

County Regional Crime Lab, an auto theft investigative technician and additional patrol cars for the increased police force.

The proposed budget also includes critical building repairs at Washington Heights Arts Center and the Glennon Heights Pool facilities. Older, aluminum traffic



signals — some that are 50 years old — would begin to be replaced with safer, more visible signals, and an additional left-turn lane on southbound Kipling Parkway for eastbound Hampden Avenue would be added. Funding to build sidewalks would increase to \$500,000 a year in 2018, which would be a two-thirds jump from the \$300,000-a-year level of the last several years.

The Community Resources Department would be able to increase its Lakewood Possibilities Fund, which provides scholarships

for families in need to participate in the City's recreation and cultural programs. The City's sustainability efforts would be bolstered with Community Resources putting 70 "Big Belly" waste and recycling bins in the parks, as recommended by a citizen's committee, and improving the

in revenue from sales tax resulting from the Colorado Mills closure, the City will use some of its "savings account" to help pay for important items in the 2018 proposed budget including the added police agents.

The City has built up a sound savings account over numerous years, mostly by not spending all of the City's approved annual budget. In the last five years, the City has spent less than the annual budget by an average of 6.5 percent. The most that was saved was in 2015 when the budget was "underspent" by 8.4 percent. The savings account allows the City's finances to weather economic fluctuations such as the Great Recession and the destructive May 8 hailstorm.

The General Fund is the largest part of the City's annual budget, accounting for 64 percent of the overall budget. This fund pays for services such as police patrols, parks maintenance and snowplowing provided to residents, and sales and use tax collected from shoppers provides 66 percent of the "income" that pays for these City services. The proposed General Fund budget for 2018 is \$123 million. The overall budget is \$202 million, which includes restricted funds that can only be spent for specific purposes.

The second and final public hearing on the proposed 2018 Annual Budget will be at the City Council's Special Meeting on Oct. 30. The budget is available at the City Clerk's Office or online at [Lakewood.org/Budgets](http://Lakewood.org/Budgets).

## Make your plans now for holiday recycling events

Halloween might be what's on your mind now, but it's not too early to make plans for the holiday season, particularly when it comes to your recycling efforts.

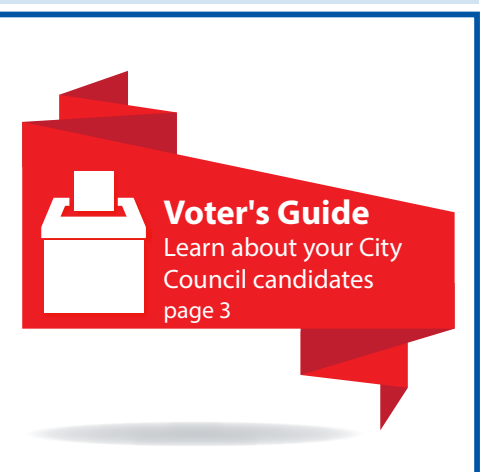
Lakewood will have its innovative annual holiday recycling events at Quail Street Recycling Center, 1068 Quail St., beginning with the vegetable cooking oil event, which will be the Saturday after Thanksgiving. On Nov. 25, you can bring your used vegetable cooking oil to pour into the designated barrel at the center, and the oil will be recycled into locally used biodiesel by Clear Ecos, the City's recycling partner on this effort. This one-day event allows you to dispose of the vegetable cooking oil you've used

throughout the year — or just on Thanksgiving — preventing it from ending up in the landfill or in the sanitary sewer system if it's washed down the drain.

As you dig out your holiday lights for decorating, if you find strings of broken lights bring those or any unused incandescent or LED holiday lights to Quail Street for recycling. Beginning Nov. 24 and running through Jan. 21, the center will take holiday light strings, without other ornamentation. MeTech Recycling, Lakewood's electronics recycling partner, will responsibly recycle the lights, diverting them from the landfill. New holiday lights that are still in the box can be donated to

the Family Tree Treasure Trunk thrift store at 5892 W. 44th Ave. in Wheat Ridge.

## Development Dialogue, budget and elections make it a busy fall

I have written in my last couple of columns about the opportunities and challenges we face in a growing metro area. To better understand the issues, the Lakewood Planning Commission has launched the Lakewood Development Dialogue and hosted three community open houses in September to seek feedback on what is working, what isn't, what needs to change and what should stay the same. The dialogue also includes a website for residents to contribute their thoughts online. Thanks to all of you who took time to participate. The meetings were well attended, and the website has been visited many times. You provided welcomed and valuable input. The Planning Commission will now have study sessions where your feedback will help shape the commission's next steps and its recommendations to City Council. It is very important to stay

One of the best things about Lakewood is our great parks, cultural events and recreational opportunities provided through our Community Resources Department. We continue to look for opportunities to add more parks and open space because it's an important way to look ahead and plan for the future. The department has finished the Imagine Lakewood Master Plan and a master plan for Lakewood Heritage Center, the City's 20th century museum. These community driven plans will set the course for improvements for arts, parks, culture, history and recreation opportunities in Lakewood for the next several years. The changing of the leaves means it's time for important city matters including the budget and elections. Let's start with the budget. I am pleased to say that Lakewood will continue to utilize your dollars responsibly and in a manner that is consistent with your priorities. Next year's investments for the proposed 2018 budget include new police agents, energy-efficient upgrades at City facilities that will save tax dollars, locker room and other upgrades at Glennon Heights Pool, traffic signal

updates and much more. (Read the budget story on page 1 or visit [Lakewood.org/Budgets](http://Lakewood.org/Budgets).) What is unique to this year's budgeting process is a significant loss of revenue. The devastating May 8 hailstorm temporarily shuttered the Colorado Mills Mall, the City's largest source of sales tax revenue. This creates a unique challenge for the 2017 budget because the mall's closure is expected to lead to a \$2.7 million loss. Because of years of strong financial management, the City has a "rainy day fund" that will allow us to continue to move forward without major impacts to the critical City services you expect and depend on. We are hopeful the mall will reopen for the holiday season and that things will get back on track.

Odd number years mean City Council elections. A seat is open in every ward, which means half of the council is up for election or re-election. Please be cautious of negativity and misinformation. Websites, blogs and social media can be great tools, but as we know, they can also be nonfactual. I encourage you to reach out to all the candidates, get to know them and why they are running. In this issue, you will find good information, and you can watch the League of Woman Voters forums at [Lakewood.org/CandidateForums](http://Lakewood.org/CandidateForums). Running for office is not easy, and I applaud all who have thrown their name in to run and wish them all the best of luck.

I would like to take a moment to recognize three members of council who will not be returning. Scott Koop is term limited and will end a run of having a Koop on council for the last 16 years, which includes Scott's wife, Debbie, serving before him. Scott is a kind and caring man with a great sense of humor. These are just a few of the ways your money is being put back into your community to keep the progress of positive changes moving forward.

Many are aware that Ward 2 is a bit different than the other wards.

Five large groups in Ward 2 provide representation through the O'Kane, Two Creeks, Northeast Lakewood, Morse Park and Eiber neighborhood organizations. # VOTER'S GUIDE

## City Council elections Nov. 7

Electing your representative for Lakewood City Council is as easy as going to your mailbox. This Nov. 7 election will be by mail ballot.

Active, registered Lakewood voters will receive a mail ballot at home listing the City Council candidates for their wards. Absentee ballots are available, and voters can also vote in-person at Voter Service and Polling Centers, where you can register to vote, drop off your mail ballot or get a replacement ballot.

Lakewood Civic Center has an outdoor ballot box on the west side of the south building at 480 S. Allison Parkway to drop off your ballot instead of mailing it through the U.S. Postal Service. If you mail your ballot at the post office, mail it early enough before the election to ensure that it is received by the 7 p.m. deadline on Tuesday, Nov. 7.

**Oct. 16-20** – Mail ballots sent to all active, registered Lakewood voters. You can check the status of the mailing of your ballot at [VoterLookup.jeffco.us](http://VoterLookup.jeffco.us).

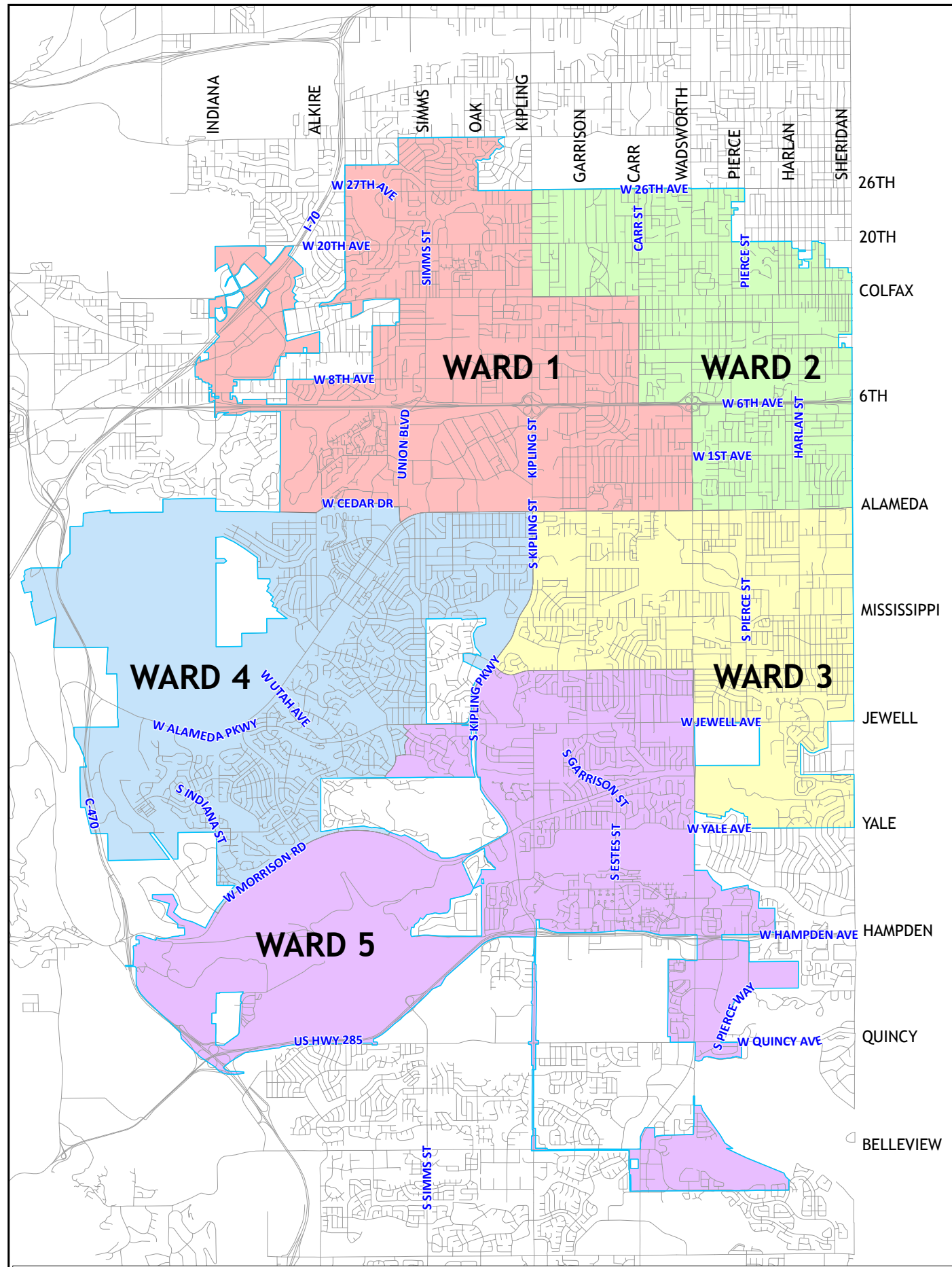
