

Dear Mr. Roome:

I respectfully submit the following Campaign Finance Complaints against Michael Bieda, candidate for City Council in Ward 3.

Complaint # 1

On or about September 2, 2021, 61 days prior to the November 2, 2021 election, a communication promoting Mr. Bieda's campaign was posted in a public place on a community bulletin board and has been otherwise publicly distributed in the community. Exhibits 1 and 2 show pictures of this communication. The communication lacks the disclaimer required by Lakewood Municipal Code (L.M.C.) §2.54.030.A.8, stating that communication is paid for by the name of the candidate committee.

The Clerk is respectfully requested to impose upon Mr. Bieda the \$250 fine stipulated by L.M.C. §2.54.050.C.(2.2).b for failure to include the required disclaimer on a communication distributed more than 30 days but less than 75 days prior to the election.

Complaint # 2

Mr. Bieda has accepted campaign contributions of \$100 or more without reporting the employer or occupation of the donor, in violation of L.M.C. §2.54.030.D.1.b.



The Clerk is respectfully requested to:

1. Notify Mr. Bieda of his ability to amend his noncompliant reports by disclosing the occupation and employer of each of these donors within 72 hours, pursuant to L.M.C. §2.54.050.B.(1.1); and
2. Refer this matter to a hearing officer for further proceedings pursuant to L.M.C. §2.54.050.B.(1.2) if Mr. Bieda fails or refuses to file such disclosures within the allotted time, and in such case order Mr. Bieda to disclose the required information pursuant to L.M.C. §2.54.050.C.5; and
3. Impose upon Mr. Bieda the sanctions required by L.M.C. §2.54.050.C.2 for filing the required disclosures of donors' occupations and employers after the mandated reporting deadlines.

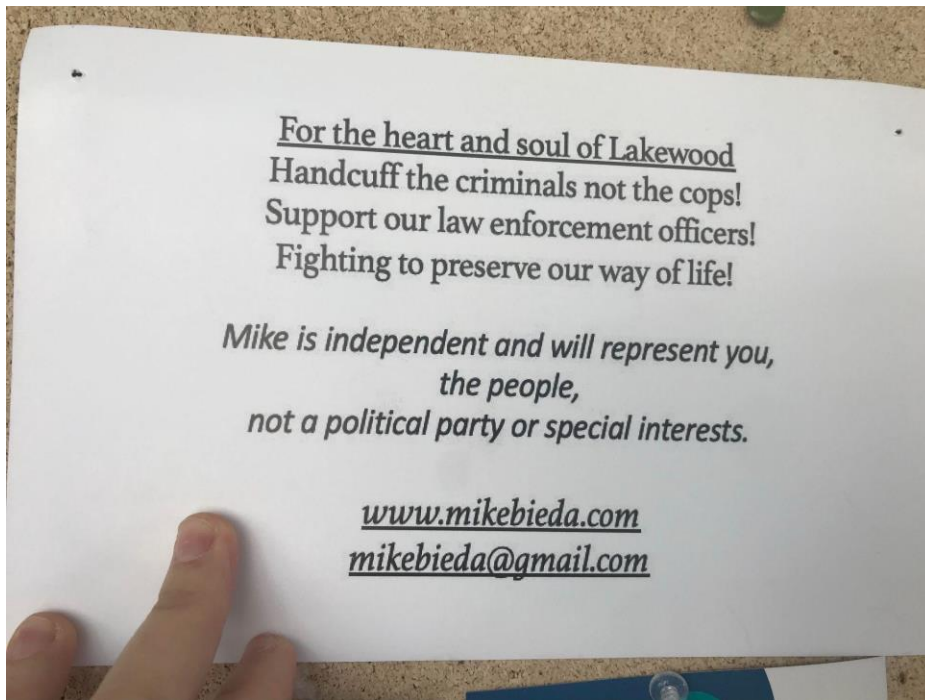
