#### ALCOHOL BEVERAGE TASTINGS PERMIT

An alcohol Beverage Tastings Permit allows a Retail Liquor Store or Liquor-Licensed Drugstore to conduct sample tastings of alcoholic beverages within their establishment. Licensees seeking an Alcohol Beverage Tastings Permit in the City of Lakewood must submit the completed application and fee no later than 30 days prior to the first tastings event or at the time of the license renewal, whichever comes first.

#### ADDITIONAL DOCUMENTS REQUIRED

- Alcohol Beverage Tastings Application
- Alcohol Beverage Tastings Schedule
- Oath of Applicant Form
- Certificate of Training for each individual conducting the tastings
- A written plan establishing how the applicant will conduct the Tastings in compliance with state statutes and the Lakewood Municipal Code
- Diagram showing where the Tastings will take place within the licensed premises.
