## DESIGN REVIEW COMMISSION INFORMATION SHEET

#### **Authority:**

Lakewood Municipal Code - 02.58.010 Lakewood Municipal Code -17.1.7.5 Ordinance O-2019-21

#### **Number of Members:**

Five members total, three urban design professionals appointed by the Lakewood City Council, a design review planner appointed by the Planning Director and a caseplanner.

#### Term:

Four years. Terms expire on March 31st.

#### **Qualifications:**

Each member must have a demonstrated interest in, competence with, or knowledge of, urban design.

At least three members must be professionals in an urban design-related discipline such as:

- o Architecture
- o Design
- o Urban Planning

The remaining two members shall be city staff and shall be selected, as much as possible, from related disciplines.

#### **Duties:**

The Design Review Commission participates in the creation of design guidelines for new development in the Lakewood area and has the authority to review design review applications within designated areas of the city. The recommendations made by the Design Review Commission are based on the criteria in adopted design guidelines.

The Design Review Commission is responsible for drafting by-laws, operating policies, and other rules of procedure, and attending yearly educational sessions, as well as other duties to call upon and receive expert opinions with respect to the broad spectrum of building matters, particularly as it relates to proposed amendments to the Building Code.

#### **Public Meeting:**

The Design Review Commission meetings are held when the commission has an item for consideration, with a minimum of four meetings per year
